The 2021 CPA Annual Meeting was held in-person (and virtually via ZOOM) at the Cult Classic Brewery in Stevensville, Kent Island, MD. After a varied luncheon of pizza, salads, breads and desserts, Coordinator Bill Smith convened the meeting at 1 PM by welcoming those who made the drive to attend the first in-person Annual Meeting since 2019, and to those attending via the ZOOM link.

Bill extended thanks to all the volunteers (trip leaders, instructors, Piracy leaders, etc.) that kept CPA afloat

during 2021. Activity is up from 2020, but still down a bit from 2019 and preceding years.

Bill recognized the outgoing Steering Committee (Lisa Arrasmith, Beth Boyd, Ralph Heimlich, Paula Hubbard, Katherine Neale, and Shelly Wiechelt) and officers Rich Stevens (Treasurer) and Sue Stevens (Membership Secretary), and noted that two members were stepping down, while two others had stepped up to be nominated for the Steering Committee.

This fall CPA lost a great friend and mentor for many of our members, Marshall Woodruff. I first met Marshall on my very first CPA paddle. I had just moved to Maryland from Florida when I signed up for one of Marshall's KIPPBURRRZ paddles around Eastern Neck Island. As it turned out it was a very blustery day with winds straight out of the north, this turned into a short paddle as expected but it did give me a glimpse of CPA paddles and an introduction to Marshall.

As I was a new member Marshall told me about the KIPP paddles, so it was always in the back of my mind when a new season started. I finally signed up for my first KIPP in 2012 and showed up for the first KIPP of the season launching from Kent Narrows on a sunny but cool April day.

I was surprised when I arrived to find about 25 paddlers with many returning old KIPPERS along to share their learned experiences. Marshall came across as a strict trip leader, but I soon learned that Marshall was teaching you more than just endurance but teaching you to be an independent accomplished paddler and leader. Marshall came across strict, but he also had a heart of gold and soon became a good friend. I can honestly say I am a much better paddler because of his mentorship.

I remember on that first KIPP paddle, this one guy kept flipping over (Robert Golden) but after a while I figured

out it was intentional because the group had to rush to his aid and perform a rescue.

This was all part of the show and a lesson to teach others how to react and to hone their rescue skills. I remember during my first few KIPP practice paddles, I had serious doubt I would be able to complete the 33.6 miles circumnavigation of Kent Island but when the final KIPP rolled around in September, I was so pumped up I felt could have pulled a skier around the island. I have participated on and off the last several years, completing the circumnavigation three times.

Marshall will be sorely missed.

Ralph will still be active leading trips and co-editor of the CPA newsletter.

Stepping down are Shelly Wiechelt, who has been the chair of SK 101 for the past two years while also serving on the Steering Committee. Shelly did a superb job and will be missed.

Ralph Heimlich has served on the Steering Committee for the past five years after serving four years as CPA Coordinator. He has been the leading trip leader for many years, organizing more trips than any other member, especially multiple kayak campers, host of the CPA Holiday party for more than 10 years and Editor and Co-editor of *The Chesapeake Paddler*. Bill expressed the hope that Ralph would remain active to help CPA continue its current success.

Bill recognized Marilyn Cooper and Gary Trotter for graciously agreeing to run for the SC and fill the vacancies created. Marilyn is co-captain of the revitalized Pirates of the Sugarloaf and Gary has been an active member for several years. Bill reiterated that volunteers are what keeps CPA alive and put out a call for all members to volunteer as trip leaders, event leaders and helpers and to run for office.

Treasurer Rich Stevens presented a <u>summary of the</u> <u>state of CPA's finances</u> for 2021. CPA continues to be in good financial shape in spite of the continuing pandemic which curtailed many activities. Our cash on hand


increased by \$1,370 (5%). The closing balance includes \$26,415 in the CPA bank account and \$371 in the PayPal account. Membership dues collected were \$3,417 up 85% from \$1,850 in 2020.

This is a dramatic turnaround from the previous three years where membership dues had been steadily decreasing, but still quite a way below pre-pandemic levels. Expenses on a number of usual activities were avoided (SK101 and SK102, the 2020 Annual Meeting and Holiday Party), but additional expenses for the ZOOM account to make possible virtual meetings were incurred.

Membership Secretary Sue Stevens <u>presented her</u> <u>report</u>. Total CPA memberships are 619, with an additional 70 or so "invisible" family members. This has remained steady, partly due to a freeze on membership expiration in 2020 due to the COVID pandemic, and partly due to an increase in renewals. 2021 membership renewals nearly doubled from 39 to 77. In 2020, CPA gained 36 new members, even though activities almost ceased. In 2021, new members nearly doubled to 65. A number of people joined or renewed immediately after the popular Zoom Cold-Water Workshops, Water Hazards training, and Basic Kayak Camping workshop, during January- March.

Ralph Heimlich presented the 2021 Participation Report.

Participation in 2021 continued to be impacted by the COVID pandemic, but showed some recovery as participants were vaccinated and returned to outdoor activity. Virtual events and a new category of winter hikes attracted participants. CPA had 25 individual trip leaders, leading a combined 84 trips or events, with 342 individual participants taking part a total of 797 times during the year.

That's 71 percent of our usual trip leader corps, 69 percent of our usual trip participation and 87 percent of our usual individual participants, based on the 2013-2019 averages. 86 people participated in 3 or more events over the season. (Note that participation in Piracies is not well documented as to number of times participating.)

The only old business was the amendment to our bylaws passed as a referendum on the 2020 ballot.

New Business


A committee of volunteers led by Laurie Collins

(including Marilyn Cooper, Paula Hubbard and Gary Trotter) have stepped up to replace Shelly Wiechelt in leading the planning for SK101, our introductory class for new and wanna-be kayakers. Look for more info to come.

SC Member Lisa Arrasmith (who was absent on vacation), sent a note promising that the proposed Maryland Fun Day at Downs Park will be rescheduled in 2022. The new reservation date is sometime in June 2022, depending on the availability of the Fernwood pavilion. Construction on Beverly Triton Beach Park is scheduled for November 1 with the arrival of the construction trailer and installation of silt fences. Talbot County kayakers are pushing back against restrictions on parking at the county public boat ramps. It's on the agenda of the Talbot County Recreation Advisory Board meeting in November. Lisa encourages all Talbot County kayakers to make their views known at the meeting.

An extended discussion was prompted by Bill Smith's observation that we need to encourage more CPA members to lead day trips so that we have a robust calendar of events in 2022. Suggestions included a simplified one-day informal course for prospective trip leaders (vs. the more detailed SK203 Trip Leader Training Course that has not been held for at least 5 years), a mentoring program and recognition of Assistant Trip

Leaders who can step up to being Trip leaders after a few trips, and a renewed emphasis on shorter, flat-water beginner-level trips for new kayakers, especially those with recreational kayaks.

Bob Maynard agreed to write up a summary of the key points for the mentoring program.

Election Results

103 ballots were cast, including on-line, mail-in and in-person ballots. The slate of officers and SC members nominated was overwhelmingly elected, with no write-in nominations. The newly elected officers stood and were applauded by the audience.

Awards

Coordinator Bill Smith presented three awards recognizing outstanding service to the club.

Beth Boyd—For outstanding service to the Chesapeake Paddlers Association in serving on the Steering Committee from 2020 to the present, and editing, publishing and managing our newsletter, *The Chesapeake Paddler*, from January 2017 to October 2019. Beth has been an active member of the Pirates of Arundell and has participated in many activities and

events since joining CPA in 2011.

Lois Wyatt—For outstanding service to the Chesapeake Paddlers Association in editing our newsletter, *The Chesapeake Paddler*, from January 2017 to October 2019. Lois has been an active member of the Pirates of Arundell and the Gunkholers, and has participated in many activities and events since joining CPA in 2005.

Marla Aron—For outstanding service to the Chesapeake Paddlers Association in managing ordering, inventory and sales of CPA logo gear from 2015 to the present. Marla has expanded the options for colors, fabrics and sizes (especially ladies' sizes) and found new manufacturers for our logo gear.

She has also been an active member of the Pirates of Arundell, the Gunkholers, the ADK Loons, and has participated in many trips and activities since joining CPA in 2004.

All awardees were present and received their plaques to thunderous applause. Coordinator Smith adjourned the meeting at 3 PM. 25 members attended in person, and 3 virtually via ZOOM.

Remembering Marshall Woodruff

May 2, 1944 - September 24, 2021

One of CPA's most beloved paddlers, Marshall Woodruff of Kensington, MD, passed away from a long-term battle with cancer on September 24, 2021.

He attended the University of Maryland in College Park and started several businesses there, including The Joint Possession, Illusions, Sagebrush, and First Impressions, selling handmade sandals and leather goods, as well as posters, jewelry and paraphernalia.

Marshall led what many might call an "alternative" lifestyle: He served two years of alternative service as a conscientious objector during the Vietnam War, was arrested for pornography for selling The Washington Free Press in his store, which was reversed on appeal in 1971, and his stores carried a variety of goods associated with the hippie lifestyle and drug culture.

After his College Park businesses closed, Marshall





opened The Cobbler Shoppe in Georgetown, voted best shoe repair shop in Washington many years running. He also made custom shoes and leather goods and constructed leather costume pieces for the Kennedy Center, Washington Ballet, and the Opera Center.

Marshall later worked at Auto Assist/Wheelchair Getaways in College Park, owned by his high school friend, Bob Kitts.

Marshall became interested in sea kayaking and joined CPA in 2003. In 2006, he launched the Kent Island Practice Paddles (KIPP) which involved a series of distance paddles each year that culminated in circumnavigating Kent Island.

KIPP was instrumental in taking a large number of CPA paddlers beyond basic skills to greater levels of

endurance, safety and confidence.

Marshall was also known for a series of paddles around Eastern Neck Wildlife Refuge in every season. He didn't let the cold weather stop him and also led KIPBURRRZ paddles during the winters. His love of kayaking led him to do a solo trip to Glacier Bay in Alaska in 2008 and to the Arctic in 2010 with fellow paddler Dave Isbell.

While living briefly in the San Francisco Bay area, Marshall was diagnosed with neck cancer in 1999. More diagnoses of cancer followed: Lymphoma

stage 4 in 2008 right after the Alaska trip and then kidney cancer in 2010 after the Arctic trip.

His last cancer diagnosis of recurring neck cancer happened in early 2021. Marshall tackled each cancer head on and worked closely with his "team" of doctors and caregivers. He was extraordinary in his ability to survive three cancers for 22 years despite having a feeding tube and tracheotomy.

He is survived by his daughter, Samantha Stoughton; grandson, Leo Dunleavy; sisters, Rosemary Polons and Anne Brown; several nieces and nephews; his companion of 35 years, Margaret Pully and many, many lifelong friends. He will be missed.

"I learned a lot about kayaking from many, but I consider Marshall my mentor. Aside from the technical aspects we spent memorable times talking about leadership on the water and responsibilities to others out there with you, how the group could always be stronger than the best individual.


"Marshall was ALWAYS in teaching mode if the opportunity presented itself.

Whether it was a KIPP or CPA outing,
Marshall always took the time to recommend a better paddle stroke, setup, gear, whatever he thought someone could improve upon.

"Once I amusedly watched (now fondly remember) a short outing on the Potomac. We crossed paths with some rec boaters and exchanged greetings. Opportunity spotted, he mentioned that one of them had their paddle upside down.

Having corrected that he then moved onto teaching a better paddle stroke to try, and finished up by speaking about the basic safety gear and why he recommended it. A spontaneous SK102 to total strangers."

Marshall created the KIPP patch that is worn with pride by those who complete the KIPP series, including the 34-mile circumnavigation of Kent Island.

Paddler Profile

Meet Alan Mindlin

Lives in: Fredericksburg, VA.

Real job: I am retired.

Do you regularly attend a CPA Piracy? No but I try to go a few times a season.

Number of years paddling? I have been paddling for 20 years.

How did you get involved in sea kayaking? I enjoy photography and I like to take photos of birds. Shore birds were always on the other side of the river so I thought if I could get a kayak and paddle to the birds I would get great photos.



My theory was flawed: I did not expect them to use their wings. It took a bit of refining to get it right.

What boat(s) do you paddle? I have a Swift Bering Sea and a Warren Light Craft Little Wing 15.5.

Rudder or skeg? I prefer a skeg since a skeg can also help stabilize a kayak in rough water.

Type of paddle used? I prefer a Greenland paddle since they are easier on the shoulders and help control a kayak better. I have a one piece Beale paddle, a 2 piece Joe-O-paddle Greenland and a Mitchell Hybrid Coastal. They also look cool.

Do you do any other paddling than sea kayaking? I used to live on Long Island and paddled the bay, sound and on a rare occasion the ocean. There is less choppy water where I live so I paddle the Rappahannock River, Lake Mooney (near house) and Lake Anna. I paddle sometimes to photograph nature.

Do you regularly do any other outdoor activities? Aside from kayaking I like to bike and do some hiking, lap swimming in my local pool, and photography.

How often do you paddle between May and October? I average 2 times a week kayaking. I need to bike to keep flexible.

Do any winter paddling? I usually paddle about 2-3 times a month in the winter. Paddling in the winter is different in Virginia than Long Island. We paddled to see the seals on Long Island and had salt water which did not freeze as fast as fresh. I paddle here with a great group of CPA paddlers during the year and the winter.

Favorite local paddling location? My favorite place to paddle is Widewater State Park. I like it because it is never crowded, it is clean with heated bathrooms and it is the closest park on the Potomac that is near my home.

I can paddle in many different directions: I can go across the river to Maryland, down south to Potomac Creek or Crow's Nest, down Aquia Creek to Government Island, or up north to Quantico.

Favorite CPA trip you've ever been on and why? My

favorite trip was not really a trip. When I moved down from New York I did not know many people and I needed some refreshing of my skills. I signed up for SK102 and got to know the members of the CPA while I improved my skills. Much thanks to some wonderful instructors.

Coolest paddling trip you've ever been on anywhere and why? When I lived in New York, I ran a kayak trip to Connecticut to the Thimble Islands and the Connecticut River. About 20 of us paddled between Deep River and Old Lyme in Connecticut.

It was fall and the colors were amazing. The Connecticut River is a scenic river and we paddled past Selden Neck State Park, which is an island. It was a beautiful trip.

Scariest/most dangerous paddling trip/incident and why? If you paddle enough something is bound to go wrong sometime. I had a rule for paddling in the winter: The temperature had to be over 40 and the wind under 15.

I broke the rule once when my friend and paddling buddy Marc, his son Justin and I decided to paddle with a 20-25 mile per hour wind because we realized we most likely would not paddle together for a long time.

Reynolds Channel, which is the final leg of the 8 mile trip, is an ocean channel and with the tide and wind we all were worried. Even though we were dressed in dry suits and wet suits it was a rocky ride. It was a challenge for all of us, with fast current and choppy water. None of us fell in, but my friend gave up winter kayaking.

Bucket list trips? I would love to paddle in Hawaii on the ocean.

Three things you like most about paddling? I started paddling for photography but I have met and made more friends paddling in the last 20 years. I love the adventure because no matter how many times you go on the same trip, something different always happens.

What do you like about CPA? The CPA is an organized group that encourages improving one's skills, providing interesting and "safe" trips and having friendly enthusiastic members.

What other paddling clubs/groups do you belong to? I will always be a member of the Long Island Paddlers and I am a proud member of The Bucket List and the Lake Ridge Paddlers.

One unusual non-paddling thing we'd be surprised to know about you? I used to collect Lionel trains and still have quite a few.


